This form is to be used if a statutory reason applies; extends the time to file a final account to 13 months.

- □ Is there a statutory reason for extending administration?
  - □ An Ohio estate tax return must be filed for the estate.
  - □ A proceeding contesting the validity of the decedent's will pursuant to section 2107.71<sup>1</sup> of the Revised Code has been commenced.
  - □ The surviving spouse has filed an election to take against the will.
  - □ The administrator or executor is a party in a civil action.
  - □ The estate is insolvent.
  - □ The decedent's will provides that a posthumously born child or heir, which includes a child or heir born through the use of assisted reproductive technologies as defined in section 5801.12<sup>2</sup> of the Revised Code, shall inherit under the will as provided in section 2107.34 <sup>3</sup> of the Revised Code.
  - □ For other reasons set forth by the administrator or executor, subject to court approval, it would be detrimental to the estate and its beneficiaries or heirs to file a final and distributive account.
    - □ If yes: Continue
    - □ If no: An Application to Extend Time (Form 410) must be completed.
- □ Is form 13.8 signed by the Fiduciary?
- □ Is there an Entry attached to the application?
- □ Is there real property?
  - □ If no: Continue
  - □ If yes:
    - □ Has the property been sold?
    - □ Has the property been transferred?
    - □ If not: Within the first six months of the administration, then the Court expects the Fiduciary to submit a plan to manage the real property in accordance with the provisions of R.C. 2113.31<sup>4</sup>.

- □ Was a Delinquent Notice (form BC 425) <u>AND</u> a Citation (form BC 417) filed by the Court for the estate?
  - □ If no: Continue.
  - □ If yes: Give to a Magistrate for approval.
- □ Has there previously been an extension given for the estate?
  - □ If no: Continue.
  - □ If yes: Give to a Magistrate for approval.
- □ If asking for more than the 13 months: Give to a Magistrate for approval
